"Tax Conformity Amendment Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-172 on first and second readings, May 14, 1985, and May 28, 1985, respectively. Following the signature of the Mayor on June 10, 1985, this legislation was assigned Act No. 6-39, published in the June 28, 1985, edition of the <u>D.C. Register</u>, (Vol. 32 page 3611) and transmitted to Congress on June 14, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-24, effective September 5, 1985.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUN 1 0 1985

To amend the District of Columbia Income and Franchise Tax Act of 1947 to redefine "Internal Revenue Code of 1954" as providing continued conformity, on a limited basis, with the federal income tax.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Tax Conformity Amendment
Act of 1985".

Sec. 2. Section 4(bb) of title 1 of the District of Columbia Income and Franchise Tax Act of 1947, effective June 11, 1982 (D.C. Law 4-118; D.C. Code, sec.

47-1801.4(28)), is amended to read as follows:

"(bb) The term 'Internal Revenue Code of 1954' means the Internal Revenue Code of 1954, approved August 6, 1954 (68A Stat. 3; 26 U.S.C. sec. 1 et seq.), as amended through October 31, 1984.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,
