"Board of Education Budget Submission Date Amendment Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-252 on first and second readings, June 25, 1985, and July 9, 1985, respectively. Following the signature of the Mayor on July 16, 1985, this legislation was assigned Act No. 6-67, published in the August 9, 1985, edition of the <u>D.C. Register</u>, (Vol. 32 page 4583) and transmitted to Congress on July 24, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-48, effective October 5, 1985.

D.C. ACT 6 - 67

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUL 1 6 1985

To change the Board of Education's budget submission date from the 1st day of October to the 21st day of December, in advance of the fiscal year.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Board of Education Budget
Submission Date Amendment Act of 1985".

Sec. 2. Section 2(h) of An Act To fix and regulate the salaries of teachers, school officers, and other employees of the board of education of the District of Columbia, approved June 20, 1906 (34 Stat. 317; D.C. Code, sec. 31-103), is amended by striking the phrase "on the first day of October" and inserting the phrase "on or before the twenty-first day of December" in its place.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,
