"Council Record Reproduction Fee Authorization Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-133 on first and second readings, April 16, 1985, and April 30, 1985, respectively. Following the signature of the Mayor on May 16, 1985, this legislation was assigned Act No. 6-19, published in the May 31, 1985, edition of the <u>D.C. Register</u>, (Vol. 32 page 2954) and transmitted to Congress on May 21, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-6, effective July 17, 1985.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAY 1 6 1985

To authorize the Secretary to the Council of the District of Columbia to establish reasonable fees for reproductions of transcripts or transcriptions of legislative meetings, committee meetings, legislative hearings, investigative hearings, and any other records that are part of the Council of the District of Columbia's official legislative files.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Council Record Reproduction Fee Authorization Act of 1985".

Sec. 2. Pursuant to section 742 of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 831; D.C. Code, sec. 1-1504), the Secretary to the Council of the District of Columbia may establish and collect reasonable fees for the reproduction of transcripts or transcriptions of legislative meetings, committee meetings, legislative hearings, investigative hearings, and any other records that are part of the Council of the District of Columbia's official legislative files.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as
