"Flat Fuel Tax Amendment Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-112 on first and second readings, October 22, 1985, and November 5, 1985, respectively. Following the signature of the Mayor on November 26, 1985, this legislation was assigned Act No. 6-105, published in the December 13, 1985, edition of the D.C. Register, (Vol. 32 page 7268) and transmitted to Congress on November 27, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-80, effective February 19, 1986.

To amend An Act To provide for a tax on motor-vehicle fuels sold within the District of Columbia, and for other purposes, to modify fuel taxes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Flat Fuel Tax Amendment Act of 1985".

- Sec. 2. Section 1 of An Act To provide for a tax on motor vehicle fuels sold within the District of Columbia, and for other purposes, effective March 4, 1981 (D.C. Law 3-128; D.C. Code, sec. 47-2301), is amended to read as follows:
- "(a) The District of Columbia shall levy and collect 15.5 cents per gallon on motor vehicle fuels within the District of Columbia, sold or otherwise disposed of by an importer or by a user, or used for commercial purposes.
- "(b) The proceeds of the taxes imposed under sections

 1 through 18 (D.C. Code, sec. 47-2301 through 47-2315) and
 the money collected from fees charged for the registration
 and titling of motor vehicles, including fees charged for
 the issuance of permits to operate motor vehicles, shall be
 deposited in the General Fund of the District of Columbia
 established under section 9 of the Revenue Funds (

D.C. Code, sec. 47-2301 Note, D.C. Code, sec. 47-131 (1986 supp.) Availability Act of 1975, effective January 22, 1976 (D.C. Enrolled Original Law 1-42; D.C. Code, sec. 47-131).".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
