D.C. LAW 6-90

"Child Abuse Amendments Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-104 on first and second readings, November 19, 1985, and December 3, 1985, respectively. Following the signature of the Mayor on December 30, 1985, this legislation was assigned Act No. 6-118, published in the January 17, 1986, edition of the D.C. Register, (Vol. 33 page 307) and transmitted to Congress on January 7, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-90, effective March 12, 1986.

D.C. ACT 6 - 118

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DEC 3 0 1985

To amend the D.C. Code to provide greater protection against child abuse.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Child Abuse Amendments
Act of 1985."

Sec. 2. The D.C. Code, section 16-2301, is amended as follows:

D.C. Code, sec. 16-2301 (1986 supp.)

- (a) Paragraph (9) is amended as follows:
- (1) Subparagraph (E) is amended by striking "." and inserting "; or" in its place; and
- (2) By adding a new subparagraph (F) to read as follows:
- "(F) who has received negligent treatment or maltreatment from his or her parent, guardian, or other custodian.".
- (b) Paragraph (23) is amended by striking the words "or molestation" and inserting ", molestation, or

exploitation" in its place.

- (c) By adding new paragraphs to read as follows:
- "(24) The term 'negligent treatment' or 'maltreatment' means failure to provide adequate food, clothing, shelter, or medical care, which includes medical neglect, and the deprivation is not due to the lack of financial means of his or her parent, guardian, or other custodian.
- "(25) The term 'sexual exploitation' means a parent, guardian, or other custodian allows a child to engage in prostitution as defined in section 2(1) of the Control of Prostitution and Sale of Controlled Substances in Public Places Criminal Control Act of 1981, effective December 10, 1981 (D.C. Law 4-57; D.C. Code, sec. 22-2701.1), or means a parent, guardian, or other custodian engages a child or allows a child to engage in obscene or pornographic photography, filming, or other forms of illustrating or promoting sexual conduct as defined in section 2(5) of the District of Columbia Protection of Minors Act of 1982, effective March 9, 1983 (D.C. Law 4-173; D.C. Code, sec. 22-2011(5)).".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
