
NOTICE

D.C. LAW 7-10

"D.C. Statehood Constitutional Convention Initiative of 1979 Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-134 on first and second readings, March 31, 1987, and April 14, 1987, respectively. Following the signature of the Mayor on May 6, 1987, this legislation was assigned Act 7-21, published in the May 22, 1987, edition of the D.C. Register, (Vol. 34 page 3286) and transmitted to Congress on May 8, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-10, effective June 24, 1987.

D.C. ACT 7 - 2 1

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAY 0 6 1987

To amend the District of Columbia Statehood Constitutional Convention Initiative of 1979 to delay for three years the first elections for the offices of Senator and Representative.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Statehood Constitutional Convention Initiative of 1979 Amendment Act of 1987".

Sec. 2. Section 4(d) of the District of Columbia Statehood Constitutional Convention Initiative of 1979, effective March 10, 1981 (D.C. Law 3-171; D.C. Code, sec. 1-113(d)), is amended as follows:

D.C. Code, sec. 1-113 (1988 supp.)

(a) By striking in paragraph (1) the year "1987" wherever it appears and inserting in its place the year "1990";

(b) By striking in the second sentence of paragraph (2) the year "1989" and inserting in its place the year "1992";


(c) By striking in the third sentence of paragraph (2) the year "1991" and inserting in its place the year "1994"; and


(d) By striking in the third sentence of paragraph (2) the year "1993" and inserting in its place the year "1996".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,




