D.C. LAW 7-138

"Wastewater System Regulation Amendment Act of 1988".

Pursuant to Section 412 of the District of Columbia Self-Sovernment and Governmental Reorganization Act, P. L. 93~198, "the Act", the Council of the District of Columbia adopted Bill No. 7-278 on first and second readings, May 17, 1988, and May 31, 1988, respectively. Following the signature of the Mayor on June 9, 1988, this legislation was assigned Act No. 7-188, published in the June 24, 1988, edition of the <u>D.C. Register</u>, (Vol. 35 page 4779) and transmitted to Congress on June 16, 1988 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-138, effective August 10, 1988.

To amend the Wastewater System Regulation Amendment Act of 1985 to provide legal authority to impose fees and charges for the issuance of pretreatment permits and the administration of the pretreatment program.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Wastewater System Regulation Amendment Act of 1988".

Sec. 2. The Wastewater System Regulation Amendment Act of 1985, effective March 12, 1986 (D.C. Law 6-95; D.C. Code, sec. 6-951 et seq.), is amended as follows:

(a) Section 8(a) (D.C. Code, sec. 6-957(a)) is amended

by adding the following new sentence at the end:

"The Mayor is authorized to set and collect fees and charges as may be necessary or appropriate to ensure compliance with this act.".

(b) Section 8(b)(6) (D.C. Code, sec. 6-957 (b)(6)) is amended by striking the phrase ", and" and inserting a

semicolon in its place.

(c) Section 8(b)(7) (D.C. Code, sec. 6-957 (b)(7)) is amended by striking the period and inserting the phrase "; and" in its place.

(d) Section 8(b) (D.C. Code, sec. 6-957(b)) is amended

by adding a new paragraph (8) to read as follows:

"(8) Regulations imposing fees and charges for the issuance of wastewater pretreatment permits and the administration of the pretreatment program that reasonably and fairly meet the costs of the administration of the pretreatment program.".

(e) Section 14(a) (D.C. Code, sec. 6-963(a)) is amended by striking the phrase "a local newspaper" and inserting the phrase "the largest circulation daily newspaper published in the District" in its place.

(f) Section 14(c) (D.C. Code, sec. 6-963(c)) is

amended to read as follows:

"(c) For the purpose of this section only, a significant violation is a violation that:

"(1) Remains uncorrected 45 days after

notification of noncompliance;

"(2) Is part of a pattern of noncompliance over a 12-month period;

"(3) Involves a failure to report accurately the

noncompliance;

"(4) Results in the District exercising its

emergency authority under section 13; or "(5) Is considered significant by the Mayor in light of the circumstances.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
