D.C. LAW 7-169

"District of Columbia Boxing and Wrestling Commission Act Amendment Act of 1988".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93~198, "the Act", the Council of the District of Columbia adopted Bill No. 7-493 on first and second readings, June 28, 1988, and July 12, 1988, respectively. Following the signature of the Mayor on July 15, 1988, this legislation was assigned Act No. 7-225, published in the July 29, 1988, edition of the <u>D.C. Register</u>, (Vol. 35 page 5749) and transmitted to Congress on July 25, 1988 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-169, effective September 29, 1988.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUL 1 5 1988

To amend the District of Columbia Boxing and Wrestling Commission Act to expand the size of the District of Columbia Boxing and Wrestling Commission, to clarify its purpose, and to require quarterly reports of its activities.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Boxing and Wrestling Commission Act Amendment Act of 1988".

Sec. 2. The District of Columbia Boxing and Wrestling Commission Act, effective October 8, 1975 (D.C. Law 1-20; D.C. Code, sec. 2-601 et seq.), is amended as follows:

- (a) Section 2 (D.C. Code, sec. 2-601) is amended by inserting after the word "regulations" the phrase ", to promote the District of Columbia as a location for boxing, wrestling, and martial arts events,".
- (b) Section 6(a) (D.C. Code, sec. 2-605(a)) is amended by:

(1) Striking the phrase "and wrestling" whenever it appears and inserting the phrase ", wrestling, and martial arts" in its place; and

(2) Striking the phrase "or wrestling" and inserting the phrase ", wrestling, or martial arts.

(c) Section 7 (D.C. Code, sec. 2-606) is amended as follows:

(1) Subsection (b) is amended by:

(A) Striking the phrase "or wrestling" wherever it appears and inserting the phrase ", wrestling, or martial arts" in its place; and

(B) Striking the phrase "and wrestling" and inserting the phrase ", wrestling, and martial arts" in its place.

(2) A new subsection (m) is added to read as follows:

"(m)(1) The Commission shall, pursuant to title 1 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1204; D.C. Code, sec. 1-1501 et seq.), issue rules to establish standards for the operation of gymnasiums and other facilities used in the training of boxers, wrestlers, kickboxers, and practitioners of martial arts, shall implement these rules, and shall license all facilities as well as inspect all facilities and

equipment subject to this subsection.

"(2) The proposed rules shall be submitted to the Council for a 45-day period of review, excluding Saturdays, Sundays, legal holidays, and days of Council recess. If the Council does not approve or disapprove the proposed rules, in whole or in part, by resolution within this 45-day review period, the proposed rules shall be deemed approved. Nothing in this section shall affect any requirements imposed upon the Mayor by title 1 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1204; D.C. Code, sec. 1-1501 et seq.).".

(d) Section 8(e) (D.C. Code, sec. 2-607(e)) is amended

to read as follows:

Section 2-607

- "(e) The Commission shall report quarterly to the Mayor and to the Council on its official acts and its efforts to promote the District of Columbia as a location for boxing, wrestling, and martial arts events. The Commission shall make recommendations, as it deems appropriate, to further the promotion of the District of Columbia as a location for boxing, wrestling, and martial arts events and to promote the effective regulation of professional and amateur boxing, wrestling, and martial arts events that are conducted or shown within the District of Columbia.".

 (e) Section 9(a) (D.C. Code, sec. 2-608(a)) is amended
- by striking the phrase "or wrestling" and inserting the phrase ", wrestling, or martial arts" in its place. ".

This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia

Statutes-at-Large, or the District of Columbia Municipal

Regulations.
