"District of Columbia Statehood Constitutional Convention Initiative of 1979 Temporary Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-126 on first and second readings, February 17, 1987, and March 3, 1987, respectively. Following the signature of the Mayor on March 19, 1987, this legislation was assigned Act 7-6, published in the April 3, 1987, edition of the <u>D.C. Register</u>, (Vol. 34 page 2153) and transmitted to Congress on March 24, 1987 for a 30-day review, in accordance with Section 602(c)(2) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-2, effective May 13, 1987.

D.C. ACT 7-6

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAR 1 9 1987

To amend, on a temporary basis, the District of Columbia Statehood Constitutional Convention Initiative of 1979 to delay for three years the first elections for the offices of Senator and Representative.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "District of Columbia
Statehood Constitutional Convention Initiative of 1979
Temporary Amendment Act of 1987".

- Sec. 2. Section 4(d) of the District of Columbia D.C. Code, sec. 1-113
 Statehood Constitutional Convention Initiative of 1979, (1988 supp.)
 effective March 10, 1981 (D.C. Law 3-171; D.C. Code, sec.
 1-113(d)), is amended as follows:
- (a) By striking in paragraph (1) the year "1987" wherever it appears and inserting in its place the year "1990";
- (b) By striking in the second sentence of paragraph
 (2) the year "1989" and inserting in its place the year
 "1992";
 - (c) By striking in the third sentence of paragraph (2)

the year "1991" and inserting in its place the year "1994"; and

(d) By striking in the third sentence of paragraph (2) the year "1993" and inserting in its place the year "1996".

Sec. 3(a). This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 225th day of its Note, D.C. Code, sec. 1-113 having taken effect. (1988 supp.)
