

D.C. LAW 7-200

"Office of Employee Appeals Appointment Amendment
Act of 1988".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-564 on first and second readings November 29, 1988, and December 13, 1988, respectively. Following the signature of the Mayor on December 21, 1988, this legislation was assigned Act No. 7-265 published in the January 6, 1989 edition of the D.C. Register, (Vol. 36 page 6) and transmitted to Congress on January 23, 1989 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-200, effective March 16, 1989.

AN ACT

D.C. ACT 7 - 265

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DEC 21 1988

To amend the District of Columbia Government Comprehensive Merit Personnel Act of 1978 to permit a member of the Office of Employee Appeals appointed to serve for the remainder of an unexpired term of three years or less to be reappointed for a full six-year term.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Office of Employee Appeals Appointment Amendment Act of 1988".


Sec. 2. The second sentence of section 601(b) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code, sec. 1-606.1(b)), is amended to read as follows: "No member may serve beyond the expiration of his or her term, except that a member serving a term of less than 6 years, who was appointed under clause (1) of this subsection, or a member who is appointed to serve the remainder of an unexpired term of three years or less, who was appointed under clause (2) of this subsection, may be reappointed for a full 6-year term."



Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia
