D.C. LAW 7-204

*Frigid Temperature Protection Amendment Act of 1988".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted 3ill No. 7-401 on first and second readings November 29, 1988, and December 13, 1988, respectively. Following the signature of the Mayor on January 6, 1989, this legislation was assigned Act No. 7-275 published in the January 20, 1989, edition of the D.C. Register, (Vol. 36 page 454) and transmitted to Congress on January 23, 1989 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-202, effective March 16, 1989.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To assure that there is a place for the homeless to seek protection from the cold on nights when the temperature falls below 26 degrees fahrenheit and to amend An Act To establish a District of Columbia Armory Board, and for other purposes, An Act To authorize the construction, maintenance, and operation by the Armory Board of the District of Columbia of a stadium in the District of Columbia, and for other purposes, and the Washington Convention Center Management Act of 1979 to specifically include emergency protection as permissable functions.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Frigid Temperature Protection Amendment Act of 1988".

Sec. 2. (a) Except as provided in subsection (b), on the nights when the temperature falls below 26 degrees fahrenheit, the Mayor shall make available appropriate space in District of Columbia ("District") buildings and facilities for any person in the District who does not have any other shelter. For the purposes of this section, "night" means the time between the hours of 6:00 p.m. on a given day and 6:00 a.m. on the following day.

(b) The Mayor shall not use District of Columbia Public School buildings currently being used for educational purposes without the prior approval of the Board of

Education.

Sec. 3. Section 1 of An Act To establish a District of Columbia Armory Board, and for other purposes, approved June 4, 1948 (62 Stat. 339; D.C. Code, sec. 2-301), is amended by inserting after the phrase "such other activities as may be in the interest of the District of Columbia" the phrase "including, but not limited to, the provision of emergency protection when the temperature falls below 26 degrees fahrenheit".

Section 5(a) of An Act To authorize the construction, maintenance, and operation by the Armory Board of the District of Columbia of a stadium in the District of Columbia, and for other purposes, approved September 7, 1957 (71 Stat. 620; D.C. Code, sec. 2-324), is amended by adding a new paragraph (12) to read as follows:

Section 2-324

"(12) To provide emergency protection when the temperature falls below 26 degrees fahrenheit.".

Sec. 5. Section 2(d) of the Washington Convention Center Management Act of 1979, effective September 17, 1979 (D.C. Law 3-36; D.C. Code, sec. 9-601(4)), is amended by inserting after the phrase "and such other activities as may be in the interest of the citizens of the District of Columbia" the phrase "including, but not limited to, the provision of emergency protection when the temperature falls below 26 degrees fahrenheit".

Sec. 6. Section 2(b) of the Emergency Shelter for Families Reform Amendment Act of 1987, effective March 11, 1988 (D.C. Law 7-68; D.C. Code, sec. 3-206.3), is amended by adding a new paragraph (3) to read as follows:

Section 3-206.3

"(3) The Mayor shall not place homeless families in congregate shelters. For purposes of this section, "congregate shelter" means a facility with 1 or more of the following characteristics:

"(1) Sleeping arrangements where different families share a common sleeping area or have individual cubicles that do not have floor to ceiling dividers and a door that can be locked; or

"(2) No private bathing or toilet facilities as prescribed by 14 D.C.M.R. sec. 401.2 (1967) or arrangements where more than 6 individuals share a bathtub shower, or toilet as prescribed by 14 D.C.M.R. sec. 602.2.(1967).

Sec. 7. Nothing in this act shall be construed to reduce the rights recognized by the District of Columbia Right to Overnight Shelter Initiative of 1984, effective May 14, 1985 (D.C. Law 5-146; D.C. Code, sec. 3-601 et seq.).

Sec. 8. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia

Statutes-at-Large, or the District of Columbia Municipal Regulations.
