"District of Columbia School of Law Interim Board of Governors Temporary Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-234 on first and second readings, May 19, 1987, and June 2, 1987, respectively. This legislation was deemed approved without the signature of the Mayor on June 23, 1987, pursuant to Section 404(e) of "the Act", and was assigned Act No. 7-41, published in the July 3, 1987 edition of the <u>D.C. Register</u> (Vol. 34 page 4199) and transmitted to Congress on June 29, 1987 for a 30-days review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-22, effective September 12, 1987

D.C. ACT 7 - 41

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUN 2 3 1987

To amend, on a temporary basis, the District of Columbia Public Postsecondary Education Reorganization Act, to expand the membership and to provide for the selection of a chairperson of the interim Board of Governors of the District of Columbia School of Law and to make certain clarifying amendments.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia School of Law Interim Board of Governors Temporary Amendment Act of 1987".

Sec. 2. Section 503(r) of the District of Columbia Public Postsecondary Education Reorganization Act, effective February 24, 1987 (D.C. Law 6-177; to be codified at D.C. Code, sec. 31-1543(r)), is amended as follows:

D.C. Code, sec. 31-1543 (1988 supp.)

- (a) By designating the existing subsection (r) as paragraph (1) of subsection (r);
- (b) By striking the phrase "4 members" and inserting in its place the phrase "5 members";
- (c) By striking the phrase "1 of whom shall be the Mayor, 1 of whom shall be the Corporation Counsel for the District of Columbia,";
- (d) By striking the phrase "Law, and" and inserting in its place the phrase "Law as of the effective date of this title,";
- (e) By adding the phrase "as of the effective date of this title," after the word "Bar";
- (f) By striking the phrase "or the immediate past President's designee." and inserting in its place the phrase "l of whom shall be the General Counsel of the Leadership Conference on Civil Rights as of the effective date of this title, l of whom shall be the Executive Director of the Far East Community Services, Inc., as of the effective date of this title, and l of whom shall be the Executive Director of the District of Columbia Association

for Retarded Citizens, Inc., as of the effective date of this title. The interim Board of Governors shall select a chairperson from among its members."; and

(g) By adding a new paragraph (2) to read as follows: "(2) The interim Board of Governors shall not use funds appropriated by the District of Columbia for the School of Law to subsidize the tuition of persons who are not residents of the District of Columbia.".

Sec. 3(a). This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 225th day of its having taken effect.
