D.C. LAW 7-24

"District of Columbia Sales Tax Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-243 on first and second readings, June 16, 1987, and June 30, 1987, respectively. Following the signature of the Mayor on July 6, 1987, this legislation was assigned Act 7-45, published in the July 17, 1987, edition of the <u>D.C. Register</u>, (Vol. 34 page 4515) and transmitted to Congress on July 10, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-24, effective September 22, 1987.

## D.C. ACT 7 - 45

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## JUL 0 6 1987

To amend the District of Columbia Sales Tax Act by excluding from taxation the sale of eligible foods purchased with federal food stamps.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Sales Tax Amendment Act of 1987".

Sec. 2. Section 128 of the District of Columbia Sales Tax Act, approved May 27, 1949 (63 Stat. 115; D.C. Code, sec. 47-2005), is amended by adding a new subsection (x) to read as follows:

"(x) Sales of "eligible foods", as defined in title 7, section 271.2 of the Code of Federal Regulations pursuant to the federal Food Stamp Act of 1977, approved September 29, 1977 (91 Stat. 958; 7 U.S.C. 2011 et seq.) ("Stamp Act"), and purchased with food stamps issued pursuant to the Stamp Act.".

Sec. 3. Section 2 of the District of Columbia Sales Tax Amendment Act of 1987 shall apply to sales made after September 30, 1987.

Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(l) of the District of Columbia Self-Government and Governmental Reorganization Act,
