"Soil and Water Conservation District Reestablishment Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-189 on first and second readings, June 30, 1987, and July 14, 1987, respectively. Following the signature of the Mayor on July 23, 1987, this legislation was assigned Act 7-67, published in the August 14, 1987, edition of the <u>D.C. Register</u>, (Vol. 34 page 5331) and transmitted to Congress on July 29, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-39, effective October 9, 1987.

# D.C. ACT 7 - 67

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## 21 2 3 1987

To amend the District of Columbia Soil and Water Conservation Act and to reestablish the Soil and Water Conservation District.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Soil and Water Conservation District Reestablishment Amendment Act of 1987".

- Sec. 2. The Soil and Water Conservation District established by section 4 of the District of Columbia Soil and Water Conservation Act of 1982, effective September 14, 1982 (D.C. Law 4-143; D.C. Code, sec. 1-2803), is reestablished as a District of Columbia government agency.
- Sec. 3. Section 5 of the District of Columbia Soil and Water Conservation Act of 1982, effective September 14, 1982 (D.C. Law 4-143; D.C. Code, sec. 1-2804), is amended by:

(a) Striking the word "established" and inserting in

its place the word "reestablished";

- (b) Striking the title "Director of the Department of Environmental Services" and inserting in its place the title "Director of the Department of Consumer and Regulatory Affairs";
- (c) Striking the title "Director of the Department of Transportation" and inserting in its place the title "Director of the Department of Public Works"; and
- (d) Striking the title "Assistant City Administrator for Planning and Development" and inserting in its place the title "Director of the Office of Planning".
- Sec. 4. The District of Columbia Soil and Water Conservation Act of 1982, effective September 14, 1982 (D.C. Law 4-143; D.C. Code, sec. 1-2801 et seq.), is amended to add a new section 17 to read as follows:

  "Sec. 17. Terms.

New, D.C. Code sec. 1-1814 (1988 supp.) "Each member of the Soil and Water Conservation Board appointed by the Mayor of the District of Columbia or by the Council of the District of Columbia shall serve a 2 year term, which shall begin on the date that a majority of these members are sworn in and expire at the conclusion of the Council period. This date shall be the anniversary date for all subsequent Mayoral and Council appointments.".

Sec. 5. Section 15 of the District of Columbia Soil and Water Conservation Act of 1982, effective September 14, 1982 (D.C. Law 4-143; D.C. Code, sec. 1-2813), is repealed.

Sec. 6. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
