D.C. LAW 7-54

"Wastewater System Regulation Amendment Temporary Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-281 on first and second readings, July 14, 1987, and September 29, 1987, respectively. Following the signature of the Mayor on October 15, 1987, this legislation was assigned Act 7-87, published in the October 30, 1987, edition of the D.C. Register, (Vol. 34 page 6895) and transmitted to Congress on October 21, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-54, effective December 10, 1987.

D.C. ACT 7 - 87

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

SCT 1 6 1987

To amend, on a temporary basis, the Wastewater System Regulation Amendment Act of 1985 to provide legal authority to impose fees and charges for the issuance of pretreatment permits and the administration of the pretreatment program.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Wastewater System Regulation Amendment Temporary Act of 1987".

Sec. 2. The Wastewater System Regulation Amendment Act of 1985, effective March 12, 1986 (D.C. Law 6-95; D.C. Code, D.C. Code, sec. 6-951 et seq.), is amended as follows:

sec. 6-957

(a) Section 8(a) (D.C. Code, sec. 6-957(a)) is amended (1988 supp.)

by adding the following new sentence at the end:

"The Mayor may set and collect fees and charges as may be necessary or appropriate to ensure compliance with this act.".

- (b) Section 8(b)(6) (D.C. Code, sec. 6-957(b)(6)) is amended by striking the phrase ", and" and inserting a semicolon in its place.
- (c) Section 8(b)(7) (D.C. Code, sec. 6-957(b)(7)) is amended by striking the period and inserting the phrase "; and" in its place.

(d) Section 8(b) (D.C. Code, sec. 6-957(b)) is amended

by adding a new paragraph (8) to read as follows:

"(8) Regulations imposing fees and charges for the issuance of wastewater pretreatment permits and the administration of the pretreatment program.".

Sec. 3(a). This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Nayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 225th day of its having taken effect.
