
NOTICE

D.C. LAW 7-81

"Juror Fees Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-215 on first and second readings, November 10, 1987, and November 24, 1987, respectively. Following the signature of the Mayor on December 10, 1987, this legislation was assigned Act 7-116, published in the December 18, 1987, edition of the D.C. Register, (Vol. 34 page 8115) and transmitted to Congress on December 21, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-81, effective March 9, 1988.

D.C. ACT 7 - 116

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DEC 10 1987

To provide for juror fees for jurors serving in the Superior Court of the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Juror Fees Act of 1987".

Sec. 2. Title 15 of the District of Columbia Code is amended as follows:

(a) By amending the table of contents for the title by striking the phrase "7. Fees and Costs..... Sections 15-701 to 15-717." and inserting in its place the phrase "7. Fees and Costs.....Sections 15-701 to 15-718.";

(b) By amending the table of contents for Chapter 7 by adding at the end the phrase "15-718. Juror fees."; and

(c) By adding a new section 15-718 to read as follows:
"Section 15-718. Juror fees.


"(a) A juror serving in the Superior Court of the District of Columbia shall be paid an attendance fee of \$30 for each day of actual attendance at the place of trial or hearing, except that jurors employed by a federal, state, or local government or by a private employer who pays regular compensation during the period of jury service shall not be paid an attendance fee.

"(b) A travel allowance not to exceed \$2 per day shall be paid to all jurors serving in the Superior Court of the District of Columbia."

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
