
NOTICE

D.C. LAW 7-88

"District of Columbia Public Hall Regulation
Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-220 on first and second readings, November 24, 1987, and December 8, 1987, respectively. Following the signature of the Mayor on December 22, 1987, this legislation was assigned Act 7-126, published in the January 8, 1988, edition of the D.C. Register, (Vol. 35 page 164) and transmitted to Congress on January 22, 1988 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-88, effective March 11, 1988.

D.C. ACT 7 - 12 6

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DEC 2 2 1987

To amend An Act making Appropriations to provide for the expenses of the Government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and three, and for other purposes, to regulate the operation of public halls.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Public Hall Regulation Amendment Act of 1987".

Sec. 2. Section 7 of An Act making appropriations to provide for the expenses of the Government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and three, and for other purposes, approved July 1, 1902 (32 Stat. 625; D.C. Code, sec. 47-2820), is amended by adding new subsections (c) and (d) to read as follows: D.C. Code, sec. 47-2820 (1988 supp.)

"(c)(1) Except as provided in paragraph (2) of this subsection, after 11:30 p.m. on Sundays through Thursdays except days preceding holidays and after 1 a.m. on Saturdays, Sundays, and legal holidays until 8 a.m. of each day, owners or managers of facilities licensed under the provisions of this section shall not permit any minor to be present on the licensed premises.

"(2) Paragraph (1) of this subsection shall not apply to owners or managers:


"(A) Of theaters when displaying moving pictures; or


"(B) Of buildings in which fairs, carnivals, exhibitions, lectures, and theatrical or dramatic performances are being conducted.

"(d) The Department of Consumer and Regulatory Affairs shall suspend the license of any licensee determined to have violated the provisions of subsection (c) of this section. The period of suspension shall not exceed 1 year for each violation. A licensee alleged to be in violation shall be

entitled to a hearing in accordance with section 109 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1208; D.C. Code, sec. 1-1509).".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
