"District of Columbia Certificate of Need Act of 1980 Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Sovernment and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted 3ill No. 7-335 on first and second readings, December 3, 1987, and January 5, 1988, respectively. Following the signature of the Mayor on January 25, 1988, this legislation was assigned Act 7-132, published in the February 5, 1988, edition of the D.C. Register, (Vol. 35 page 710) and transmitted to Congress on January 28, 1988 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-90, effective March 16, 1988.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JAN 2 5 1988

To amend the District of Columbia Certificate of Need Act of 1980 to authorize the State Health Planning and Development Agency to adopt detailed regulations concerning the provision of uncompensated care by health care providers seeking certificates of need.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Certificate of Need Act of 1980 Amendment Act of 1987".

- Sec. 2. The District of Columbia Certificate of Need Act of 1980, effective September 16, 1980 (D.C. Law 3-99; D.C. Code, sec. 32-301 et seq.), is amended as follows:
- (a) Section 6(a)(2) (D.C. Code, sec. 32-305(a)(2)) is amended to read as follows:
- "(2) The applicant, if it operates on a fee-for-service basis and has not given assurances pursuant to section 603(e) or section 1532(c)(6)(e) of the Public Health Service Act, approved July 1, 1944 (58 Stat. 682; 42 U.S.C. 291c(e) or 300n-1(c)(6)(e)), has given equivalent assurances to the SHPDA and is in compliance with any assurances given pursuant to this subsection in a previous certificate of need application.".
- (b) Section 6(a) (D.C. Code, sec. 32-305(a)) is amended by adding a new paragraph (3) to read as follows:
- "(3) In adopting regulations in accordance with section 17, the SHPDA shall adopt, within 90 days, comprehensive, detailed regulations to ensure that compliance with the assurances given pursuant to this subsection is achieved and maintained by the applicant. The SHPDA may adopt identical or separate regulations for facilities described in paragraphs (1) and (2) of this subsection.".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the

Council of the District of Columbia override the veto), as provided by section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
