D.C. ACT 8 - 8

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAR 21 1989

To amend, on a temporary basis, section 16-2301 of the District of Columbia Code to specify that certain individuals charged with the possession of firearms in or within 500 feet of a public school building, property, or a public school-sponsored event shall not be charged as a "child" as defined.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Public School Firearm Prohibition Temporary Act of 1989".

Sec. 2. Section 16-2301(3) is amended as follows:

Section
16-2301

(a) By striking "or" in subparagraph (B);

(b) By striking the "." at the end of subparagraph (C) and inserting the phrase "; or" in its place; and


(c) By adding a new subparagraph (D) to read as follows:

(D) charged with the possession or control of a firearm within a District of Columbia public school building, on public school property, or at a public school-sponsored event or within 500 feet of a public school building, public school property, or public school-sponsored event."


Sec 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect.





D.C. LAW 8-1

"District of Columbia Public School Firearm Prohibition -Temporary Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-130 on first and second readings, February 14, 1989, and February 28, 1989, respectively. Following the signature of the Mayor on March 21, 1989, this legislation was assigned Act No. 8-8, published in the March 31, 1989, edition of the D.C. Register, (Vol. 36 page 2246) and transmitted to Congress on March 22, 1989 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-1, effective May 16, 1989.
