NOTICE

D.C. LAW 8-145

"District of Columbia Retirement Reform Act
of 1979 Amendment Act of 1990".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-487 on first and second readings, March 27, 1990, and April 10, 1990, respectively. Following the signature of the Mayor on April 26, 1990, this legislation was assigned Act No. 8-201, published in the May 11, 1990, edition of the D.C. Register, (Vol. 37 page 2977) and transmitted to Congress on May 2, 1990 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-145, effective June 22, 1990.

AN ACT

D.C. ACT 8 - 201

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

APR 26 1990

To amend the District of Columbia Retirement Reform Act of 1979 to provide for an increase in the annuity payable from the Retirement Fund to minor children of members of the uniformed services of the District of Columbia who due to the death of the member are left without a surviving parent.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Retirement Reform Act of 1979 Amendment Act of 1990".

Sec. 2. Section 3 of the Policemen and Firemen's Retirement and Disability Act, approved August 21, 1957 (71 Stat. 396; D.C. Code, sec. 4-622), is amended as follows:

4-622

(1) Subsection (c)(2) is amended to read as follows:

"(2) In the case of a member or former member who is not survived by a wife or husband:

"(A) 75% of the member's average pay at the time of death, divided by the number of eligible children;

"(B) In the case of a member who was an officer or member of the United States Park Police Force, the United States Secret Service Uniformed Division, or the United States Secret Service Division:

"(i) 75% of the basis upon which the former member's annuity at the time of death was computed, divided by the number of eligible children.

"(ii) \$1,860; or

"(iii) \$5,580 divided by the number of eligible children.

"(C) In the case of a member who was an officer or member of the Metropolitan Police force or the Fire Department of the District of Columbia, 75% of the adjusted average pay of the former member, divided by the number of eligible children."

(2) Subsection (e) (D.C. Code, sec. 4-622(e)) is amended as follows:

(A) Paragraph 2 is amended to read as follows:

"(2) The annuity of any child under this section shall begin on the 1st day of the month in which the member or former member dies, and the annuity shall terminate upon whichever of the following occurs 1st:

"(A) The child becomes 18 years of age or, if over 18 years of age and incapable of self-support, becomes capable of self-support;

"(B) The child marries; or

"(C) The child dies."

(B) Paragraph (3) is amended to read as follows:

"(3)(A) The annuity of any student child under this section shall begin on the 1st day of the month in which the member or former member dies, and the annuity shall terminate upon whichever of the following occurs 1st:

"(i) The student child marries;

"(ii) The student child ceases to be a student;

"(iii) The student child reaches 22 years of age; or

"(iv) The student child dies.

"(B) For the purposes of this paragraph, a student child whose 22nd birthday falls on or after July 1st shall not be considered to have reached 22 years of age until the June 30th following the student child's actual 22nd birthday."

Sec. 3. To carry out the purposes of this act, the Mayor shall, pursuant to section 142(d)(1) of the District of Columbia Retirement Reform Act of 1979, approved November 17, 1979 (93 Stat. 866; D.C. Code, sec. 1-722(d)(1)) ("D.C. Retirement Reform Act"), appoint an enrolled actuary to perform the required actuarial study. The cost of the actuarial study shall be borne by the District of Columbia Police Officers and Fire Fighters' Retirement Fund. The actuarial study shall be completed by June 10, 1990.



Sec. 4. The increased benefits provided for in the District of Columbia Retirement Act of 1979 Amendment Act of 1990 shall begin to accrue on April 10, 1990, but shall not be paid until the change in benefits becomes effective pursuant to section 142(d)(1) of the D.C. Retirement Reform Act.



Sec. 5. This act shall take effect after a 30-day period of Congressional review following approval by the

Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
