D.C. ACT 8 - 257

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 17 1990

To designate two north-south alleys in Square 367, bounded by N Street, N.W., O Street, N.W., 9th Street, N.W., and 10th Street, N.W., as "Naylor Court, N.W.".

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Naylor Court, N.W., Designation Act of 1990".

Sec. 2. Pursuant to section 401 and notwithstanding section 404 of the Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Code, sec. 7-451), the north-south public alleys in Square 367, bounded by N Street, N.W., O Street, N.W., 9th Street, N.W., and 10th Street, N.W., are hereby designated as "Naylor Court, N.W.".

Note, Section 7-451

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia

Statutes-at-Large, or the District of Columbia Municipal Regulations.
