D.C. LAW 8-165

"District of Columbia Statutory Savings Provision Act of 1990".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-552 on first and second readings, June 12, 1990, and June 26, 1990, respectively. Following the signature of the Mayor on July 12, 1990, this legislation was assigned Act No. 8-230, published in the July 27, 1990, edition of the $\underline{D.C.}$ Register, (Vol. 37 page 4827) and transmitted to Congress on July 16, 1990 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-165, effective September 26, 1990.

D.C ACT 8 - 230

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUL 1 2 1990

To provide a savings provision for repealed or expired acts of the Council of the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Statutory Savings Provision Act of 1990".

Sec. 2. Savings provision.

Section 49-304

- (a) The repeal of any act of the Council shall not release or extinguish any penalty, forfeiture, or liability incurred pursuant to the act, and the act shall be treated as remaining in force for the purpose of sustaining any proper action or prosecution for the enforcement of any penalty, forfeiture, or liability, unless the repealing act expressly provides for the release or extinguishment of any penalty, forfeiture, or liability.
- (b) The expiration of any act of the Council shall not release or extinguish any penalty, forfeiture, or liability incurred pursuant to the act, and the act shall be treated as remaining in force for the purpose of sustaining any proper action or prosecution for the enforcement of any penalty, forfeiture, or liability, unless the expiring act expressly provides for the release or extinguishment of any penalty, forfeiture, or liability.
- Sec. 3. Child Support Guidelines amendment.
 Section 16-916.1(q) of the Child Support Guidelines
 Amendment Act of 1990, signed by the Mayor on May 30, 1990
 (D.C. Act 8-208; to be codified at D.C. Code, sec.
 16-916.1), is amended by striking the phrase "ONE CHILDREN" and inserting the phrase "THREE CHILDREN" in its place.

Sec. 4. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the
