# D.C. ACT 8 - 10 8

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

### MOV 0 2 1989

To amend section 16-2307 of the District of Columbia Code to specify that a person under the age of 18 years charged with the possession of a firearm in or within 500 feet of a public school building or property or a public school sponsored event may be charged as an adult.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Public School Firearm Prohibition Act of 1989".

Sec. 2. Section 16-2307(a) of the District of Columbia Code is amended as follows:

Section 16-2307

- (a) By striking "or" in paragraph (2);(b) By striking the "." at the end of paragraph (3) and inserting the phrase "; or" in its place; and
- By adding a new paragraph (4) to read as follows: "(4) a child under the age of 18 years is charged with the illegal possession or control of a firearm in or within 500 feet of a District of Columbia public school building, public school property, or a public school-sponsored event."
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia

Statutes-at-Large, or the District of Columbia Municipal Regulations.
