
NOTICE

D.C. LAW 8-86

"District of Columbia Public Assistance Act of 1982 Conforming Amendments Amendment Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-391 on first and second readings, November 21, 1989, and December 5, 1989, respectively. Following the signature of the Mayor on December 21, 1989, this legislation was assigned Act No. 8-136, published in the January 5, 1990, edition of the D.C. Register, (Vol. 37 page 48) and transmitted to Congress on January 23, 1990 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-86, effective March 15, 1990.

AN ACT

D.C. ACT 8 - 196

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DEC 21 1989

To amend the District of Columbia Public Assistance Act of 1982 to conform to the requirements of the Family Support Act of 1988.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Public Assistance Act of 1982 Conforming Amendments Amendment Act of 1989".

Sec. 2. Title V of the District of Columbia Public Assistance Act of 1982, effective April 6, 1982 (D.C. Law 4-101; D.C. Code, sec. 3-205.1 et seq.), is amended as follows:

(a) The second sentence of section 505(1) (D.C. Code, Section 3-205.5 sec. 3-205.5(1)) is amended by inserting the word "not" after the word "shall".

(b) Section 511 (D.C. Code, sec. 3-205.11) is amended Section 3-205.11 as follows:

(1) By amending subsection (a) as follows:

(A) By amending paragraph (1) by striking the figure "\$75" and inserting the figure "\$90" in its place;

(2) By amending paragraph (2) as follows:

(A) By striking the phrase "\$160 per month per child" and inserting the phrase "\$175 per month per child 2 years of age or over" in its place; and

(B) By striking the phrase "a maximum of \$120 if the individual has worked less than 120 hours in the month" and inserting the phrase "a maximum of \$200 per month per child for a child under 2 years of age" in its place;

(3) By amending paragraph (5) as follows:

(A) By striking the phrase "not already disregarded"; and

(B) By inserting a new sentence after the 1st sentence to read as follows:

"The \$30 plus one-third disregard for individuals found otherwise eligible will be applied before the disregards specified in paragraph (2) of this subsection and after the disregard specified in paragraph (1) of this subsection."; and


(4) By adding a new paragraph (5A) to read as follows:

"(5A) Disregard any Federal Earned Income Tax Credit received."

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.




