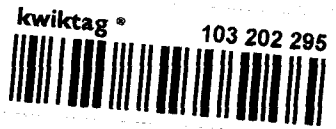

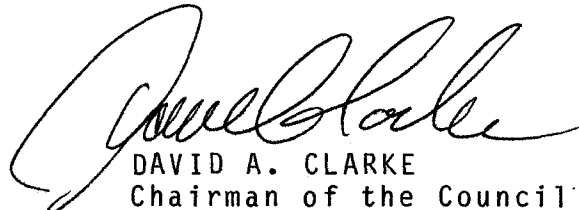
NOTICE

D.C. LAW 8-98

"Comprehensive Merit Personnel Act Adverse
Actions Amendment Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-268 on first and second readings, January 2, 1990, and January 16, 1990, respectively. Following the signature of the Mayor on January 26, 1990, this legislation was assigned Act No. 8-150, published in the February 9, 1990, edition of the D.C. Register, (Vol. 37 page 1058) and transmitted to Congress on February 1, 1990 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-98, effective March 24, 1990.

AN ACT

D.C. ACT 8 - 150

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JAN 26 1990

To amend the provision of the District of Columbia Government Comprehensive Merit Personnel Act of 1978 relating to adverse actions.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Comprehensive Merit Personnel Act Adverse Actions Amendment Act of 1989".

Sec. 2. Section 1601(d) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code, sec. 1-617.1(d)), is amended as follows:

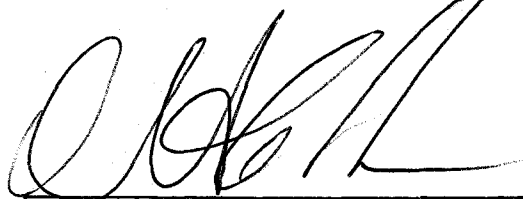
(a) Paragraph (16) is amended to read as follows:
"(16) Other conduct during and outside of duty hours that would affect adversely the employee's or the agency's ability to perform effectively."; and

(b) A new paragraph (22) is added to read as follows:
"(22) Conviction of a misdemeanor, when the conviction is based on conduct that would affect adversely the employee's or the agency's ability to perform effectively. A plea of guilty, or a conviction following a plea of nolo contendere, to a charge of a misdemeanor involving the specified conduct, shall constitute prima facie evidence of the elements of the misdemeanor."

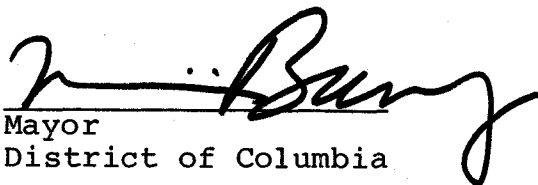
Sec. 3. Within 60 days of the effective date of this act, the Mayor shall, pursuant to title 1 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1204; D.C. Code, sec. 1-1501 et seq.), issue proposed rules to implement the provisions of this act. The proposed rules shall be submitted to the Council for a 45-day period of review, excluding Saturdays, Sundays, legal holidays, and days of Council recess. If the Council does not approve or disapprove the proposed rules, in whole or in part, by resolution within this 45-day review period, the proposed rules shall be deemed approved.

Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

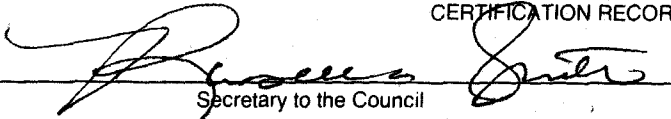

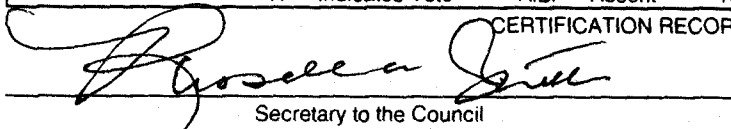
