D.C. LAW 9-28

"Day Care Policy Budget Conformity Amendment Act of 1991".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-161 on first and second readings, June 4, 1991, and June 18, 1991, respectively. Following the signature of the Mayor on July 2, 1991, this legislation was assigned Act No. 9-55, published in the July 12, 1991, edition of the <u>D.C. Register</u>, (Vol. 38 page 4211) and transmitted to Congress on July 9, 1991 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that this legislation became effective on the date that the President of the United States signed P. L. 102-105* on August 17, 1991, and therefore, cites this enactment as D.C. Law 9-28, effective August 17, 1991.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 2, 1991

To amend the Day Care Policy Act of 1979 to suspend the automatic consumer price index of payment rates to licensed child development centers, child development homes, and in-home caregivers until 1993, and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Day Care Policy Budget Conformity Amendment Act of 1991".

Sec. 2. The Day Care Policy Act of 1979, effective September 19,

1979 (D.C. Law 3-16; D.C. Code §3-301 et seq.), is amended as follows: (a) Section 10 (D.C. Code §3-309) is amended as follows: (1) Subsection (e) is amended by striking the phrase "The Department shall report to the Mayor and" and inserting the phrase "The Mayor shall report to" in its place;	Section 3-309
(2) Subsection (h)(1) is amended by striking the number	
"1990" and inserting the number "1992" in its place.	
(3) Subsection (h)(2) is amended by striking the number	
"1990" and inserting the number "1993" in its place.	
(b) Section 11 (D.C. Code §3-310) is amended as follows:	Section

"1990" and inserting the number "1992" in its place.

Sec. 3. Applicability.

Note, Section 3-310

- (a) For the period from October 1, 1990 and until the effective date of the Day Care Policy Budget Conformity Amendment Act of 1991 the rates established for licensed child development centers, child development homes, and in-home caregivers shall be increased by 4.7%.
- (b) Beginning on the effective date of the Day Care Policy Budget Conformity Amendment Act of 1991 the rates for licensed child development centers, child development homes, and in-home caregivers in effect pursuant to the Day Care Policy Act shall revert to the rates in effect on September 1, 1990.
- Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia

to override the veto) as provided in section 602 (c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
