#### D.C. LAW 9-71

"District of Columbia World Cup Soccer Ticket Sales Promotional Amendment Act of 1991".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-123 on first and second readings, November 5, 1991, and December 3, 1991, respectively. Following the signature of the Mayor on December 20, 1991, this legislation was assigned Act No. 9-122, published in the January 3, 1992, edition of the <u>D.C. Register</u>, (Vol. 39 page 19) and transmitted to Congress on January 7, 1992 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-71, effective March 11, 1992.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 20, 1991

To amend the District of Columbia Sales Tax Act to allow a sales tax exemption for tickets sold at the 1994 World Cup Soccer Games.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia World Cup Soccer Ticket Sales Promotional Amendment Act of 1991".

Sec. 2. Section 128 of the District of Columbia Sales Tax Act, approved May 27, 1949 (63 Stat. 115; D.C. Code §47-2005) is amended as follows:

Section 47-2005

- (a) Subsection (y) is amended by striking the period at the end and inserting "; or" in its place; and
  - (b) A new subsection (z) is added to read as follows:
    - (z) Sales of tickets sold for the 1994 World Cup Soccer Games.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
