
NOTICE

D.C. LAW 9-86

"District of Columbia Income and Franchise Tax Act of 1947 Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-344 on first and second readings, December 3, 1991, and January 7, 1992, respectively. The legislation was deemed approved without the signature of the Mayor on January 29, 1992, pursuant to Section 404(e) of "the Act", and was assigned Act No. 9-149, published in the February 7, 1992, edition of the D.C. Register, (Vol. 39 page 716) and transmitted to Congress on January 30, 1992 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-86, effective March 20, 1992.

D.C. ACT 9-149

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JANUARY 29, 1992

To amend the District of Columbia Income and Franchise Tax Act of 1947 to exclude interest on the obligations of the District of Columbia, a state, a territory of the United States, or any political subdivision thereof, in the computation of District gross income of individuals, estates and trusts.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Income and Franchise Tax Act of 1947 Amendment Act of 1992".

Sec. 2. Section 2 (a)(1) of title III of the District of Columbia Income and Franchise Tax Act of 1947, approved July 16, 1947 (61 Stat. 335; D.C. Code §47-1803.2(a)(1)), is amended to read as follows:

"(1) Interest upon the obligations of a state, territory of the United States, or any political subdivision thereof, but not including the District of Columbia, shall be included in the computation of District gross income: EXCEPT, That individuals, estates and trusts shall not include interest on the obligations of the District of Columbia, a state, a territory of the United States, or any political subdivision thereof, in the computation of District gross income."

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of
